


HE RINGA RAUPĀ (TRADES) SCHOLARSHIP APPLICATION GUIDELINES 2025

KEY CRITERIA: Applicants must:

- I. Have attended Kohanga Reo for a minimum of two years (attach verification of attendance)
- II. Be enrolled full-time with a registered New Zealand trade training provider or employer, or Tertiary institute in the year of application (**evidence must be provided**)
- III. Be undertaking a vocational training programme, studying towards a trade qualification, or undertaking a trade apprenticeship (evidence must be provided)

ELIGIBILITY:

Use the following flowchart to determine your eligibility to apply for one of the He Manu Pīrere no te Kōhanga Reo He Ringa Raupā (Trade) Scholarships:



ADDITIONAL REQUIREMENTS: Applicants are also required to provide the following:

Wāhanga: Tuhituhi (Criteria 300 words = 0.5 - 1 page*)

In 300 words, provide an overview of your experience within Te Kōhanga Reo, and the contribution that te reo Māori has made in your journey, including your area of study.

All applications must be received on or before the closing date with supporting documentation.

IMPORTANT INFORMATION:

- 1. Please check your application before submitting. Incomplete or late applications will be deemed ineligible and declined automatically.
- Any change(s) to details in the application (including missing or corrected information), must be advised in writing (email or post) and received at Te Kōhanga Reo National Trust Offices (67 Hankey Street, Mt Cook, Wellington 6011) by the closing date.
- 3. Te Kōhanga Reo National Trust does not accept responsibility for lost or delayed applications caused by incorrect mailing instructions or delay in delivery.

- 4. All applicants must have been enrolled at, and attended Kōhanga Reo, for a period of two (2) years or more. Supporting evidence of attendance must be provided with your application.
- 5. Applicants can only be awarded one scholarship once. You cannot apply for the same scholarship twice (in more than one year), but you may apply for the other scholarships.
- 6. All scholarships have a set dollar value. If there are no applicants, or less than the required amount, the value of those scholarships will remain the same.
- 7. He Ringa Raupa (Trades) scholarships are available to Kōhanga Reo graduates currently enrolled in full-time tertiary-level vocational studies, at a New Zealand Tertiary institution, which includes Wānanga, PTEs and other TEOs, or with a registered trade training provider or employer. Evidence of enrolment or apprenticeship and verified course/training details must be supplied with your application.
- 8. All applicants will be notified of the outcome of their scholarship application in writing, within two months of the scholarship closing date.
- 9. Successful scholarship recipients will be invited to participate in an awards ceremony within three (3) months of the date the decisions are communicated.
- 10. Successful scholarship recipients who withdraw from their course or do not continue with their studies will be required to refund the scholarship in full.
- 11. If the applicant is successful, he/she agrees to be available for any promotions, interviews organised by TKRNT.
